

## SPMA Registrar's Report As of January 12, 2006

**Clubs:** We have a total of 53 clubs registered for 2006 (compared to 55 for 2005, 53 for 2004, 57 for 2003, 54 for 2002 and 55 for 2001). North County Aquatics has not re-registered. We have several new clubs: Calabasas Tennis and Swim Center (CTSC), Ketchum-Downtown YMCA (KDYM), San Clemente Swim Masters (SCSM), and Viva Las Vegas Masters (VLVM). In addition we have club SPMA, so unattached swimmers can compete at Worlds. Within the next couple of days I should receive the Conejo Simi Aquatics Masters (CSAM) and Slowtwitch.com (SLO). We are way far ahead of any previous year in terms of number of clubs registered in early January.
